SUBJECT:	ANNUAL VENDOR TRAINING REQUIREMENT EFFECTIVE
	NOVEMBER 29, 2017
Purpose	Vendor Alert 2017-05 is a 30-Day Notice for the completion of the Annual Vendor Training Requirement.
	The California Department of Public Health / Women, Infants, and Children (CDPH/WIC) Division is notifying all WIC authorized vendors that they must complete and certify their participation in the 2017 Annual Vendor Training.
	WIC authorized vendors are being advised that CDPH/WIC has made changes to the delivery method and certification requirement for the Annual Vendor Training. All authorized vendors currently participate in Annual Vendor Training in the form of a newsletter received through the U.S. Mail. Effective November 29, 2017, vendors will be required to certify participation in the Annual Vendor Training using the Vendor WIC Information eXchange (VWIX) system.
Background	Each vendor must certify completion of the annual training, within thirty (30) days of their receipt of the annual training, certifying participation and understanding of the materials. Failure to complete the annual training and certify participation within thirty (30) days from the date of notice will result in termination of the vendor agreement.
Authority	All vendors or their designated representatives must participate in annual training provided by the Department as required by Title 7 Code of Federal Regulations part 246.12(h)(3)(xii), Title 22 California Code of Regulations section 40733 and WIC Bulletin Regulations (W.B.R.) section 71800, Vendor Training.
Action for	Beginning November 29, 2017, venders must led into the V/WIX system to

Beginning November 29, 2017, vendors must log into the VWIX system to Action for review and certify participating in the 2017 Annual Training. Vendors will be Vendors required to complete a statement of acknowledgement indicating that they have reviewed and understand the training materials. Those who fail to certify may be terminated.
