TO: ALL WIC VENDORS

SUBJECT: FRESH PRODUCE PACKAGES WITH UPC MUST BE MAPPED TO A PLU

Purpose

The California Department of Public Health, Women, Infants and Children Division (CDPH/WIC) is notifying all WIC authorized vendors that packaged fresh produce must now be mapped by Universal Product Code (UPC) to a Price Look-

Up code (PLU) in the California Authorized Product List (APL).

Background

Produce mapping is a functionality of your integrated Point of Sale (POS) software that allows you to link a UPC for a WIC authorized packaged fresh produce product (fruit or vegetable) to a PLU. CDPH/WIC's PLU list is taken from the International Federation for Produce Standards (IFPS) list. The list has been edited to remove items that are not CDPH/WIC authorized, such as herbs, dried vegetables, bulk dry beans.

Action for **Vendors**

If your store uses stand-beside devices for California WIC Card (WIC Card) transactions, you do not need to take any action.

If your store uses an integrated POS for WIC Card transactions, you must ensure that the UPC for WIC authorized fresh packaged produce is mapped to a PLU that is on the APL. For example, this may be a bag of baby carrots from a distributor or a container of cut, mixed fruit from the deli section.

Never map frozen or canned fruits and vegetables or other types of WIC foods; only map fresh fruits and vegetables.

Please consult with your POS provider for specific details about how to complete PLU mapping on your system.





The chart below details mapping for WIC authorized fresh produce:

Product	Mapped to:
Fresh fruit or vegetable PLU	Most similar PLU from CA APL
Organic fresh fruit or vegetable PLU	Most similar organic PLU from CA APL (starts with a 9)
Fresh fruit or vegetable UPC	Most similar PLU from CA APL
Store-assigned PLU or UPC	Most similar PLU from CA APL
Mixed Product UPC	PLU 4469
Organic Mixed Product UPC	Organic PLU 94469
