
Influenza and Other Respiratory Viruses Weekly Report

California Influenza Surveillance Program

Highlights (Week 41: October 8–14, 2017)

Statewide Activity



Note: This report includes data from many sources of influenza surveillance and it should be viewed as a preliminary "snapshot" of influenza activity for each surveillance week. Because data are preliminary, the information may be updated in later reports as additional data are received. These data should not be considered population-based or representative of all California public health jurisdictions.

A. Outpatient and Inpatient Data

1. Influenza Sentinel Providers

Sentinel providers (physicians, nurse practitioners, and physician assistants) situated throughout California report on a weekly basis the number of patients seen with influenza-like illness (ILI) and the total number of patients seen for any reason. ILI is defined as any illness with fever (≥100°F or 37.8°C) AND cough and/or sore throat (in the absence of a known cause other than influenza).

A total of 70 enrolled sentinel providers have reported data for Week 41. Based on available data, the percentage of visits for ILI during Week 41 was 1.5% compared to Week 41 (1.6%) and is above expected levels for this time of year (Figure 1).

The seasonal baseline was calculated using a regression model applied to data from the previous five years. Two standard deviations above the seasonal baseline is the point at which the observed percentage of ILI is significantly higher than would be expected at that time of year.

2. Kaiser Permanente Hospitalization Data

Inpatients at Kaiser Permanente facilities with an admission diagnosis including the keywords "flu," "influenza," "pneumonia," or variants of the keywords are defined as pneumonia and influenza (P&I)-related admissions. The number of P&I admissions is divided by the total number of hospital admissions occurring in the same time period to estimate the percentage of P&I admissions. Admissions for pregnancy, labor and delivery, birth, and outpatient procedures are excluded from the denominator.

The percentage of hospitalizations for pneumonia and influenza (P&I) in Kaiser Permanente facilities in northern California during Week 41 was 3.8% compared to Week 40 (3.2%) and is within expected levels for this time of the year (Figure 2).

The seasonal baseline was calculated using a regression model applied to data from the previous five years. Two standard deviations above the seasonal baseline is the point at which the observed percentage of pneumonia and influenza hospitalizations in Kaiser Permanente hospitals in northern California is significantly higher than would be expected at that time of year.

3. Influenza-Associated Hospitalizations, California Emerging Infections Program

The California Emerging Infections Program (CEIP), Influenza Surveillance Network (FluSurv-NET) conducts population-based surveillance for laboratory-confirmed influenza-associated hospitalizations among patients of all ages in Alameda, Contra Costa, and San Francisco counties.

Data for weeks 40 and 41 are not presented because results are still being collected and are likely to change.

B. Laboratory Update – Influenza


1. Respiratory Laboratory Network (RLN) and Clinical Sentinel Laboratory Surveillance Results

Laboratory surveillance for influenza and other respiratory viruses involves the use of data from clinical sentinel laboratories (hospital, academic, and private laboratories) and public health laboratories in the Respiratory Laboratory Network located throughout California. These laboratories report the number of laboratory-confirmed influenza and other respiratory virus detections and isolations on a weekly basis.

The percentage of influenza detections in clinical sentinel laboratories in Week 41 (3.1%) was the same as Week 40 (3.1%) (Figure 3). Additional details, including influenza typing and subtyping information from public health laboratories, can be found in Figures 3 and 4 and Tables 1 and 2.

Neither the RLN nor CDPH-VRDL has identified any influenza viruses by polymerase chain reaction (PCR) that are suggestive of a novel influenza virus.

Figure 4. Number of Influenza Detections by Type and Subtype Detected in the Respiratory Laboratory Network, 2017–2018



2. Antiviral Resistance Testing

Of the influenza specimens tested by the CDPH-VRDL to date this season, none have been found to be resistant to Oseltamivir (Table 3).


C. Laboratory-Confirmed Severe Influenza-associated Case Reports

Currently, as mandated under Section 2500 of the California Code of Regulations, deaths among patients aged 0–64 years with laboratory-confirmed influenza are reportable to CDPH. The weekly influenza report includes confirmed deaths formally reported to CDPH during October 1, 2017–October 14, 2017 (Weeks 40 and 41).

One laboratory-confirmed influenza-associated fatality was reported to CDPH during week 41. To date, CDPH has received one report of a laboratory-confirmed influenza-associated deaths among patients <65 years of age during the 2017–2018 influenza season.

During the summer months (late-May–September), CDPH received reports of 13 influenza-associated deaths in patients <65 years; three of these had onset during this period.

*Earliest date associated with the illness was used for cases without reported date of symptom onset.


D. Influenza-Associated Outbreaks

Two laboratory-confirmed influenza outbreaks were reported to CDPH during week 41. To date, CDPH has received two reports of a laboratory-confirmed outbreaks during the

2017-2018 influenza season.

During the summer months (late-May–September), CDPH received reports of 21 influenza-confirmed outbreaks; seven of these had onset during this period.

E. California Border Region Influenza Surveillance Network Data


The border influenza surveillance network is comprised of outpatient provider sentinel sites whose geographical coverage extends approximately 100 kilometers (60 miles) north of the California-Baja California border and includes Imperial and San Diego Counties, as well as some parts of Riverside County.

1. Syndromic Surveillance Update

A total of 7 border region sentinel providers reported data during Week 41. The total number of patients screened by all sentinel sites for ILI during Week 41 was 4,654. Outpatient ILI activity was 1.1% in Week 41. ILI activity for the California border region during Week 41 was higher when compared to activity for the same week during the

2015–2016 and the 2016–2017 seasons (Figure 7). All influenza syndromic data summarized for the border region represents a subset of CDC influenza sentinel providers in California.

Figure 7. Percentage of Influenza-like Illness Visits among Patients Seen by Sentinel Providers — California Border Region, 2015–2018




2. Virologic Surveillance Update

Cumulatively this season, a total of 439 respiratory specimens were tested from border region sentinel clinical laboratories; of these, 13 (3.0%) tested positive for influenza (10 [76.9%] influenza A; 3 [23.1%] influenza B). A total of 7 influenza positive specimens have been detected at border region RLN laboratories, of which, 7 (100%) were influenza A. Of the 7 specimens that tested positive for influenza A at RLN laboratories, 7 (100%) were subtyped as A (H3).

For Week 41, a total of 215 respiratory specimens were tested from border region sentinel clinical laboratories; of these, 9 (4.2%) tested positive for influenza (7 [77.8%] influenza A; 2 [22.2%] influenza B). A total of 4 influenza positive specimens were detected at border region RLN laboratories, of which, 4 (100%) were influenza A. Of the 4 specimens that tested positive for influenza A at RLN laboratories, 4 (100%) were subtyped as A (H3). Laboratory data summarized in Figure 8 include data from influenza clinical sentinel laboratories as well as laboratory data from border region RLN laboratories.

F. Other Respiratory Viruses

1. Laboratory-Confirmed Severe Respiratory Syncytial Virus Case Reports

Currently, as mandated under Section 2500 of the California Code of Regulations, deaths among children aged 0–4 years with laboratory-confirmed respiratory syncytial virus (RSV) are reportable to CDPH. The weekly influenza report includes confirmed deaths formally reported to CDPH during October 1, 2017–October 14, 2017 (Weeks 40 and 41).

During Week 41, no laboratory-confirmed RSV fatalities were reported. To date, CDPH has received no reports of laboratory-confirmed RSV-associated deaths among children <5 years of age during the 2017–2018 influenza season.

2. Other Respiratory Virus Laboratory Update





Figure 10. Percentage of Other Respiratory Pathogen Detections at Clinical Sentinel Laboratories, 2017-2018

During Week 41, 1,551 specimens were tested for RSV and 15 (1.0%) were positive, which was higher than Week 40 (0.8%) (Figure 9). During Week 41, parainfluenzavirus activity increased, rhinovirus/enterovirus activity decreased, and human metapneumovirus, adenovirus, and coronavirus activity remained stable (Figure 10).

Figure 9. Percentage of RSV Detections at Clinical Sentinel Laboratories, 2013-2018

Activity Levels:

No Activity: No laboratory-confirmed cases of influenza and no reported increase in the number of cases of ILI.

Sporadic: Small numbers of laboratory-confirmed influenza cases or a single laboratory-confirmed influenza outbreak has been reported, but there is no increase in cases of ILI.

Local: Outbreaks of influenza or increases in ILI cases and recent laboratory-confirmed influenza in a single region of the state.

Regional: Outbreaks of influenza or increases in ILI and recent laboratory confirmed influenza in at least two but less than half the regions of the state with recent laboratory evidence of influenza in those regions.

Widespread: Outbreaks of influenza or increases in ILI cases and recent laboratory-confirmed influenza in at least half the regions of the state with recent laboratory evidence of influenza in the state.

California Regions:

Northern: Alpine, Amador, Butte, Colusa, Del Norte, El Dorado, Glenn, Humboldt, Lake, Lassen, Mendocino, Modoc, Nevada, Placer, Plumas, Sacramento, Shasta, Sierra, Siskiyou, Sutter, Tehama, Trinity, Yolo, and Yuba counties

Bay Area: Alameda, Contra Costa, Marin, Napa, Solano, San Francisco, San Mateo, Santa Clara, Santa Cruz, and Sonoma counties

Central Valley: Calaveras, Fresno, Inyo, Kings, Mono, Madera, Mariposa, Merced, Monterey, San Benito, San Joaquin, Stanislaus, Tulare, and Tuolumne counties **Upper Southern:** Kern, Los Angeles, San Luis Obispo, Santa Barbara, and Ventura counties

Lower Southern: Imperial, Orange, Riverside, San Bernardino, and San Diego counties
