Influenza Update - Week 3 (January 18 - January 24, 2009)

National Influenza Activity

During week 3 (January 18-24, 2009), influenza activity continued to slowly increase in the United States. Five hundred eighty-eight (15.8%) specimens tested by U.S. World Health Organization (WHO) and National Respiratory and Enteric Virus Surveillance System (NREVSS) collaborating laboratories and reported to CDC/Influenza Division were positive for influenza. The proportion of deaths attributed to pneumonia and influenza (P&I) was below the epidemic threshold. The proportion of outpatient visits for influenza-like illness (ILI) was below the national baseline. The New England region reported ILI above its' region-specific baseline. Two states reported widespread influenza activity, 14 states reported regional activity; 12 states reported local influenza activity; and the District of Columbia, Puerto Rico and 22 states reported sporadic influenza activity. One human infection with a novel influenza A virus was reported.

California Influenza Activity

During week 3 (January 18-24, 2009), laboratory detections of influenza and influenza-like illness (ILI) began trending up in Northern California. As a result, influenza activity in California was upgraded to "local" (defined by CDC as outbreaks of influenza or increases influenza-like illness (ILI) cases and laboratory-confirmed influenza in a single region of the state).





Inpatient "Flu" Admissions 2004-2009 Northern California Kaiser




Inpatient "Flu" Admissions 2004-2009 Southern California Kaiser



Kaiser Pharmacy Data Influenza Antiviral Usage 2004-2009





^{*}Sentinel laboratories are hospital, academic, private, and public health laboratories located throughout California that provide data on the number of laboratory-confirmed influenza and other respiratory virus detections and isolations. The Respiratory Laboratory Network (RLN) is a network of 23 local public health laboratories that offer enhanced diagnostic testing with the "R-mix" shell vial assay, which detects several respiratory pathogens, including influenza A and B viruses, respiratory syncytial virus, parainfluenza virus, and adenovirus. Some RLN labs also offer PCR testing for influenza A and B.





Virologic Characterization at VRDL and Local Public Health Laboratories

Out of 114 influenza specimens characterized so far, both influenza A (87) and influenza B (27) have been identified. Results to date for influenza subtypes and antigenic characterization (strain-typing) are shown below; "low reactors" are influenza viruses that do not appear by hemagluttinin inhibition assay to match current vaccine strains and are sent to CDC for further characterization.



Antiviral Resistance

In December 2008, a Health Advisory was issued by the CDC providing interim recommendations for use of antiviral medications given the observation of high levels of resistance to oseltamivir in influenza A/subtype H1 viral isolates. Identification of subtype following confirmation of influenza A infection may be very useful in situations such as institutional outbreaks (e.g. long term care facilities or prisons), where implementation of mass treatment or chemoprophylaxis with antivirals is considered. Subtyping is available at some local public health laboratories as well as VRDL. Throughout the season the CDPH Viral and Rickettsial Disease Laboratory will continue to perform surveillance for antiviral resistance and provide periodic updates.
