Strategy A: Improve Availability of HIV Care

- A poster called, "Prepping Providers for Pre-Exposure Prophylaxis (PrEP) Implementation: Findings from California Office of AIDS' (OA) Local Site Evaluation of Project PRIDE PrEP Training Activities" was presented at the National HIV Prevention Conference on Wednesday, March 20, 2019.
- An oral presentation called, "Understanding Pre-Exposure Prophylaxis (PrEP) Uptake

Among Trans Women, Trans Men, and Gender Non-Binary Persons: California Office of AIDS' (OA) Local Specific Evaluation of Project PrIDE PrEP Activities” will be presented at the National Transgender Health Summit on April 13, 2019 or April 14, 2019 (TBD).

PrEP Assistance Program (PrEP-AP):

- Effective January 30, HepB (Hepatitis B Vaccine (Recombinant), Adjuvanted), a two-dose hepatitis B virus vaccine, was added to the PrEP-AP formulary. - Effective March 1, PrEP-AP clients insured by Kaiser are able to access PrEP at Kaiser pharmacies without using their Gilead co-payment coupon card or paying any money out of pocket. PrEP-AP enrollment workers are still required to enroll clients in the Gilead Co-Payment Assistance Program. - As of March 19, there are 152 PrEP-AP enrollment sites covering 63 clinics that currently make up the PrEP-AP Provider Network. As of March 26, there are 1,475 clients enrolled in the PrEP-AP. See the chart below and continued on page 3.

Since the inception of the Access, Adherence, and Navigation Program in January of 2018, 487 AIDS Drug Assistance Program (ADAP) clients have been transitioned to health coverage (Covered California health plan, off-exchange

Strategy K: Increase and Improve HIV Prevention and Support Services for People Who Use Drugs

In its most recent progress report to CDC, the Prevention Branch described the 2018 guidance OA provided to LHJs to improve capacity to deliver HIV prevention and other necessary services for people who inject drugs (PWID), as well as the responses OA received from LHJs. LHJs submitted work plans to OA throughout the last quarter of 2018, and the activities described include a host of new and expanded initiatives to prevent disease transmission and improve the overall health and wellness of PWID.

Of the 20 jurisdictions in the California Project Area, 12 reported that they plan to conduct a community assessment of readiness to provide harm reduction services and increase access to sterile syringes. Ten jurisdictions plan to strengthen infrastructure for currently-authorized SSPs, expand current services, or establish new SSPs. Six jurisdictions, including two with currently authorized SSPs, intend to initiate plans to increase the availability of Non-Prescription Sale of Syringes (NPSS) in pharmacies. The Office of AIDS has released new reports, “Epidemiology of HIV in California” for years 2015, 2016, and 2017. These companion reports to the previously released Surveillance Reports provide an epidemiologic profile and statewide overview of HIV in California, and help measure progress toward meeting OA’s getting to zero goals and objectives.
