

California Jurisdictions Known to Have Minimum Age Requirements for Clerks to Sell Tobacco Products

California state law does not have a minimum age requirement for a clerk to sell tobacco products. Local laws vary. The table below lists jurisdictions that specify a minimum age for a clerk to sell tobacco products. This list is not intended to be all-inclusive. If your county or city is not on this table, please contact your local health department's tobacco control program to confirm whether the county or city has a law requiring a minimum age for a clerk to sell tobacco products.

For the counties and cities in the table below, please review the local tobacco retail license ordinance carefully in order to understand the specific requirements for retailers in that jurisdiction. Ordinance information may be obtained from each local health department's tobacco control program.
