New Program Approach: Two Separate Tests

1. Cell-free DNA (cfDNA) for chromosome abnormalities

- A genetic screen that examines fetal DNA circulating in maternal blood
- Trisomy 21 (Down syndrome)
 Trisomy 18
 Trisomy 13
- □ Fetal sex, if requested by the participant/provider
- Offered at 10 weeks of gestation or later
- Fee: \$232, covered by Medi-Cal or patient insurance & includes follow-up services
- Availability of follow-up genetic counseling and diagnostic services for screen-positive individuals at state-approved Prenatal Diagnosis Centers (PDCs)



New Program Approach: Two Separate Tests

2. MSAFP Screening for Neural Tube Defects

- A biochemical screen that measures maternal serum alpha-fetoprotein (MSAFP)
- Anencephaly
 - Spina bifida
 - Abdominal wall defects
- Offered from 15 weeks through 21 weeks 0 days of gestation
- Fee: \$85, covered by Medi-Cal or patient insurance & includes follow-up services
- Availability of follow-up genetic counseling and diagnostic services for screenpositive individuals at state-approved Prenatal Diagnosis Centers (PDCs)

September 18, 2022
Last day for a 1 st trimester blood draw for biochemical screening

Comprehensive approach for patient education through patient video and new patient booklet

- Describes the benefits and limitations of prenatal screening
- Describes the difference between prenatal screening and diagnostic testing
- Availability of follow-up genetic counseling and diagnostic services for screen-positive, high-risk individuals





Prenatal Screening Program Redesign Elements

High-quality screening for the three most common autosomal trisomies: trisomy 21, trisomy 18 & trisomy 13

• Consistent with current medical standard of care as presented in ACOG Practice Bulletin No. 226 and ACMG Statement, Genetics in Medicine, Vol. 18, Number 10, October 2016

Equitable access to screening and follow-up services

- Universal access for pregnant California residents
- Fee covered by Medi-Cal and health insurance plans
- Affordable price for self-insured or uninsured
