Prenatal Screening Results Portal Announcement

The Genetic Disease Screening
Program is developing a Prenatal
Screening Results Portal. This
web-based portal will be available
to California prenatal providers to
access real-time patient results for
the California Prenatal Screening
Program. Any offered Follow-up
actions, authorized by the PNS
Program, will accompany these
test results.

Who will have access?

Medical doctors licensed with the Medical Board of California, Nurses registered with the California Board of Registered Nursing, and Genetic counselors licensed with the State of California.

Patients **will not** be granted access to the portal.

User accounts and passwords will be self-managed, like any web-based self-service account.

How will I look up a patient?

Providers will be required to know:

First name, last name, date of birth, PNS form number: referred to as the "test requisition number" located on the PNS test request form.

How will this impact me?

Providers that order prenatal screening tests will continue to receive paper result mailers. If a patient's test results change, a modified result mailer will be generated and mailed as usual, however updated results will be available to the provider via the Prenatal Screening results portal. Providers will no longer have to wait for PNS case coordinators to fax updated results, this should help improve time and efficiency of patient care.

New results faxing policy restrictions:

Provider requests to PNS Program Coordinators for Faxed patient results will be restricted once the Prenatal Screening Results Portal is launched. Clinicians who routinely refer patients for care at prenatal diagnosis centers (PDCs), for genetic counseling, and other diagnostic services will need to include either the patient's PNS result mailer and/or the PNS form number on their PDC referral forms to avoid interruptions of patient care until and after the Prenatal Screening Results Portal goes live.

Faxing Policy Restrictions

Providers who are dependent on faxed results due to delays in their institution's scanning department or mailing system are encouraged to begin working with their institution now to find solutions prior to portal launch.

The Genetic Disease Screening
Program is expecting to release the
Prenatal Screening Results portal
during the latter part of 2020. A
launch date and roll out plan will be
announced. We will continue to
send PNS Program communications
to keep you informed. You can also



Please remember: The law requires all prenatal care providers to give the "Important Information for Parents about Screening Your Newborn" booklet to your pregnant patients in the third trimester. The newborn screening test is mandatory, and a heel-stick specimen will be collected at the birth facility between 12 and 48 hours after birth. Over 80 genetic diseases are included on the California newborn screening panel. Through newborn screening, early diagnosis and treatment can prevent death and disability.
