Subject: Information Provided by the Local Agency at Certification

Item: WIC Participant Rights and Responsibilities

PURPOSE:

To ensure that family representative/caretakers are informed of their rights and responsibilities for participation in the WIC program.

POLICY:

 Local agency (LA) staff must ensure that the family representative/caretaker reads the Know Your Rights and Responsibilities (R&R) form, watches the R&R section of the Welcome to WIC video, or has the R&R form read by LA staff, understands and signs at initial certification, recertification, and when transferring from out-of-state with a verification of certification (VOC).

PROCEDURE(S):

- I. Once eligibility has been determined at initial certification or recertification, LA staff must do the following:
 - A. Ensure that the family representative/caretaker reads the *R&R* form, watches the *R&R* section of the Welcome to WIC video, or has the *R&R* form read by LA staff.
 - 1. When the *R&R* is read by the family representative/caretaker or the video is watched, LA staff must:
 - a. Verify that the *R&R* form was read or the video was watched.
 - b. Read all of the information in the signature box to the family representative/caretaker.
 - c. Ensure understanding by asking if there are any questions and provide answers if necessary.
 - d. Give a copy of the *R&R* form to the family representative/caretaker, if requested.
 - 2. When the *R&R* is not read by the family representative/caretaker, LA staff must:
 - a. Offer more time to the participant to read the form or to watch the video. If not, LA staff must read the form to the participant.
 - Read all of the information in the signature box to the family representative/caretaker.
 - c. Ensure understanding by asking if there are any questions, and provide answers if necessary.
 - d. Give a copy of the *R&R* form, if requested.
 - B. Have the family representative/caretaker electronically sign *R&R* in WIC WISE to certify they understand their rights and responsibilities.
 - C. The electronic signature is retained in WIC WISE.

- D. When electronic signature cannot be obtained or LA staff cannot document verbal confirmation to write in the e-signature box on the family representative/caretaker's behalf, a signed R&R must be scanned into WIC WISE. Refer to WPPM 1000-140.
- II. LA staff cannot require the family representative/caretaker to sign any LA-created agreements or contracts as a condition of program participation, in addition to the R&R form, unless approved by CDPH/WIC.
