1. Service Overview

Contractor agrees to provide to the California Department of Public Health (CDPH) the services described herein.

This agreement will implement a two-month pilot of SafelyYou's fall prevention program for dementia care in a 38-resident wing in Eskaton Greenhaven, a skilled nursing facility (SNF). The SafelyYou program is based on providing better support for unwitnessed falls through Artificial Intelligence (AI)-enabled cameras, which monitor patients continuously and record video only when a fall is detected. During the two-month pilot, the cameras will detect falls and collect data. The data collected will enable staff to understand how falls are occurring, allow staff to perform accurate root cause analysis, and assist staff in taking steps to reduce fall risk.

Per the Federal Code of Regulations §488.433, CDPH has authority to contract with this vendor to provide these local assistance services.

2. Service Location

The services shall be performed at Eskaton Greenhaven, located at 455 Florin Rd, Sacramento, CA 95831.

3. Service Hours

The services shall be provided during normal State working hours of 8 a.m. to 5 p.m., Monday through Friday, excluding state official holidays.

D. Either party may make changes to the information above by giving written notice to the other party. Said changes shall not require an amendment to this agreement.

5. Services to be Performed

Contractor shall perform the following services:

- A. Networking Infrastructure Ethernet cabling will be run from the nearest electrical closet (within 300ft of the furthest resident room) to the Memory Care unit resident's rooms. The electrical closet must have electricity and internet access dedicated for SafelyYou-*Guardian* and its networking equipment to be operational.
- B. Cameras Installation of 38 Al-enabled cameras. The placement will be determined by the installer maximizing the field of view to detect falls. The placement may need to be altered by Eskaton Greenhaven staff or contracted vendor at a later date if the camera is not functional, furniture is moved or replaced, or if residents move. Any additional cameras or wiring may incur additional fees.

- C. SafelyYou-Discover The application will be configured specifically to Eskaton Greenhaven's current information. This will include the data entry of Residents, Rooms, Cameras, and Users. SafelyYou's automated detection system records response time, number of falls, and Emergency Room visits from falls. Participants will be compared to 4-month baseline and to non-participants.
- D. After initial installation, Eskaton Greenhaven administrative users will have the ability to make edits to the basic information to ensure the application has the current content.
- E. Eskaton Greenhaven will provide CDPH with the data detailed in Part VIII of Exhibit A, Attachment I, Proposal for CMP Funds, within 6 months of completion of 2-month pilot. SafelyYou will cover the recurring costs of the program during the 2-month pilot period and if successful, Eskaton Properties, Inc. will cover the recurring costs thereafter.
